**The UK Border Agency announces special temporary arrangements for Maldivian student visa applications**

*22 August 2010, Male'*; The UK Border Agency announced special arrangements for processing the applications for student visas from the Maldives for courses beginning in autumn 2010 (on or before 31 October, 2010).

Students who submit their visa applications between Wednesday 8 and Tuesday 14 September will have their applications processed in 5 working days. This means that students will be able to apply for a visa and get back their documents during one visit to Sri Lanka.

Maldivian students need to make an appointment at the visa application centre in Colombo before they visit by emailing [ukstudentcolombo@vshelpline.com](mailto:ukstudentcolombo@vshelpline.com). They should specify in the subject box of the email that they are a Maldivian student and require an appointment between 8 and 14 September. VFS will have a number of dedicated appointments for Maldivian students only between these dates. Any applications submitted outside these dates will not be considered under the faster processing arrangements. It is important that applicants follow the current Tier 4 guidance carefully, complete their applications fully and submit the correct supporting documents. There have been some significant changes to the Tier 4 student visa policy in 2010. These include the requirement that all adult (General) Tier 4 students who have a Confirmation of Acceptance for Studies (CAS) issued after 12 August for study below degree level, excluding foundation degrees and English language courses, need to pass a UK Border Agency-approved Secure English Language Test (SELT) before they apply for a visa. If applicants submit fraudulent documents or false information, their visa applications will be refused. They also face an automatic ban on entry to the UK for the next 10 years for any category of visa.
